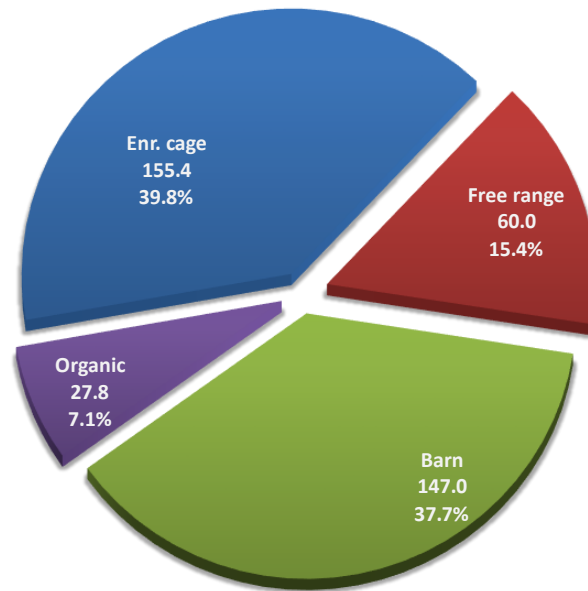

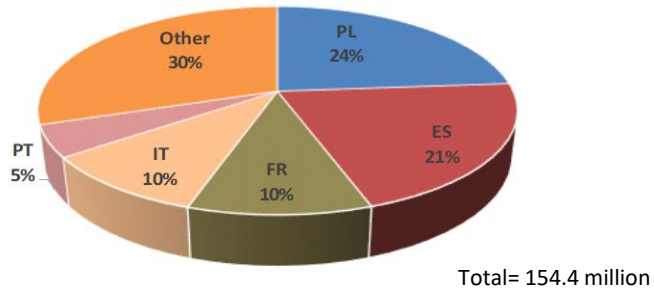

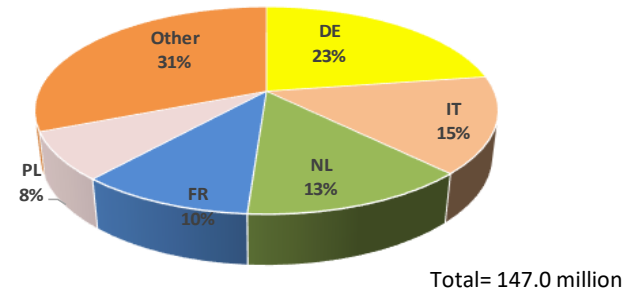

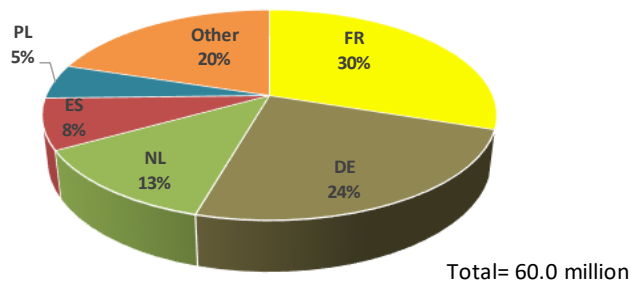
Number of laying hens
Enriched cage - 2022



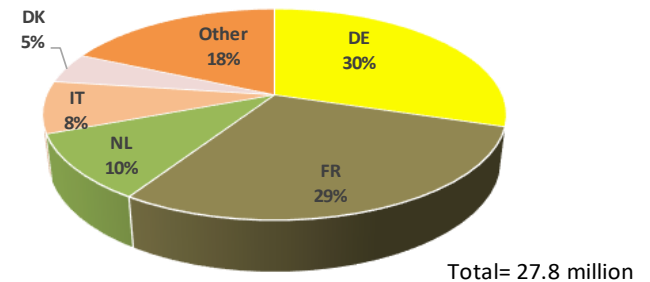
Number of laying hens

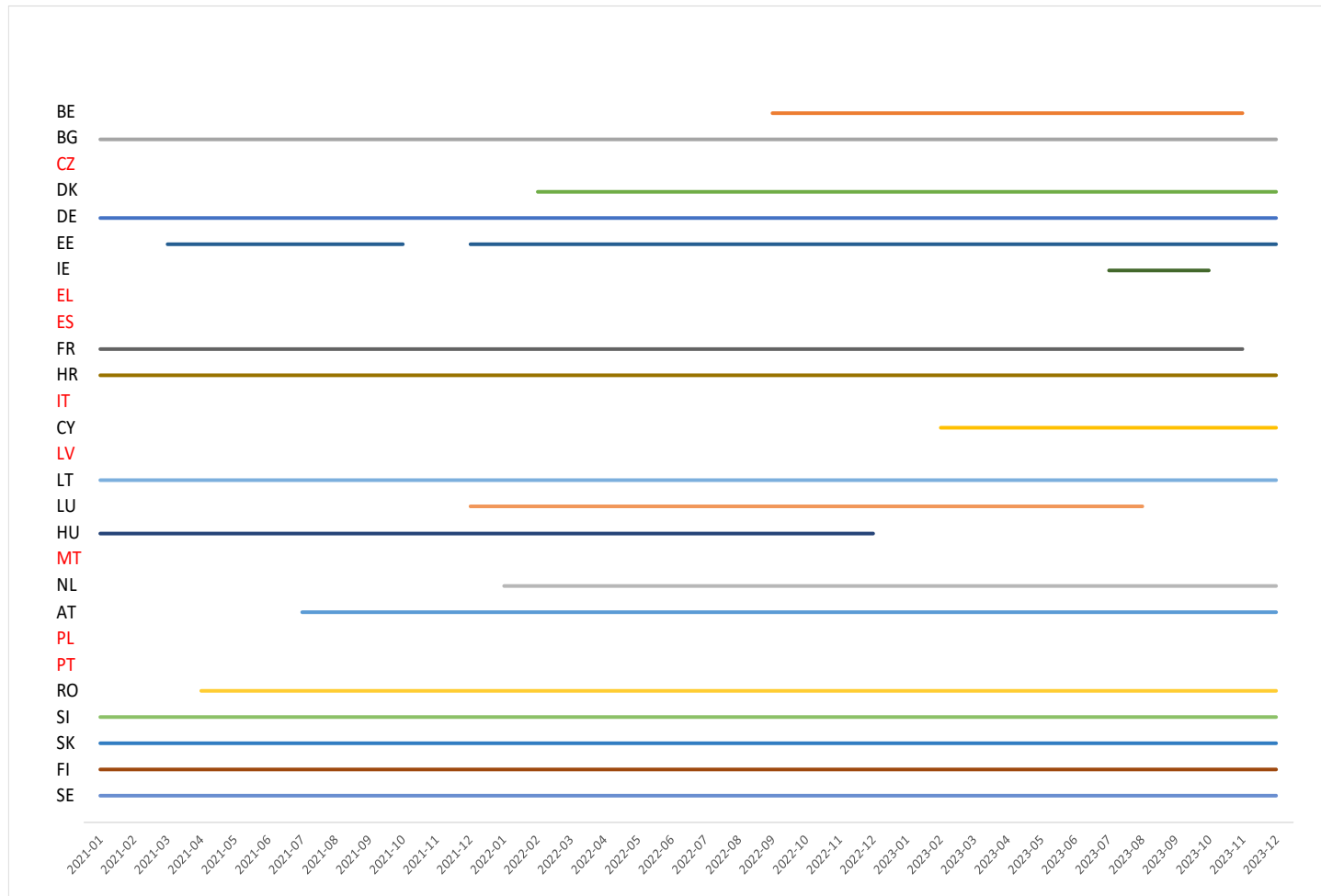

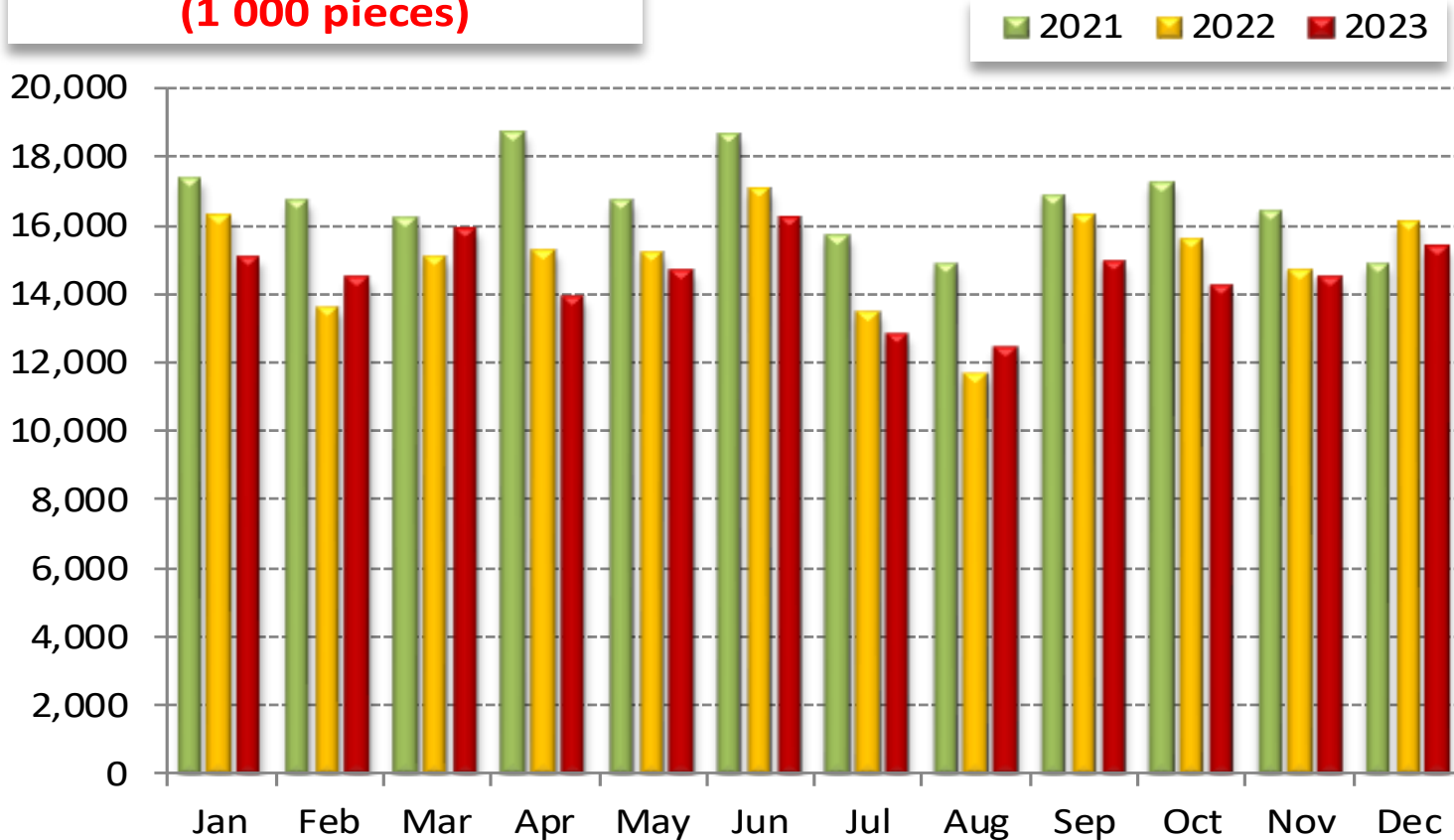

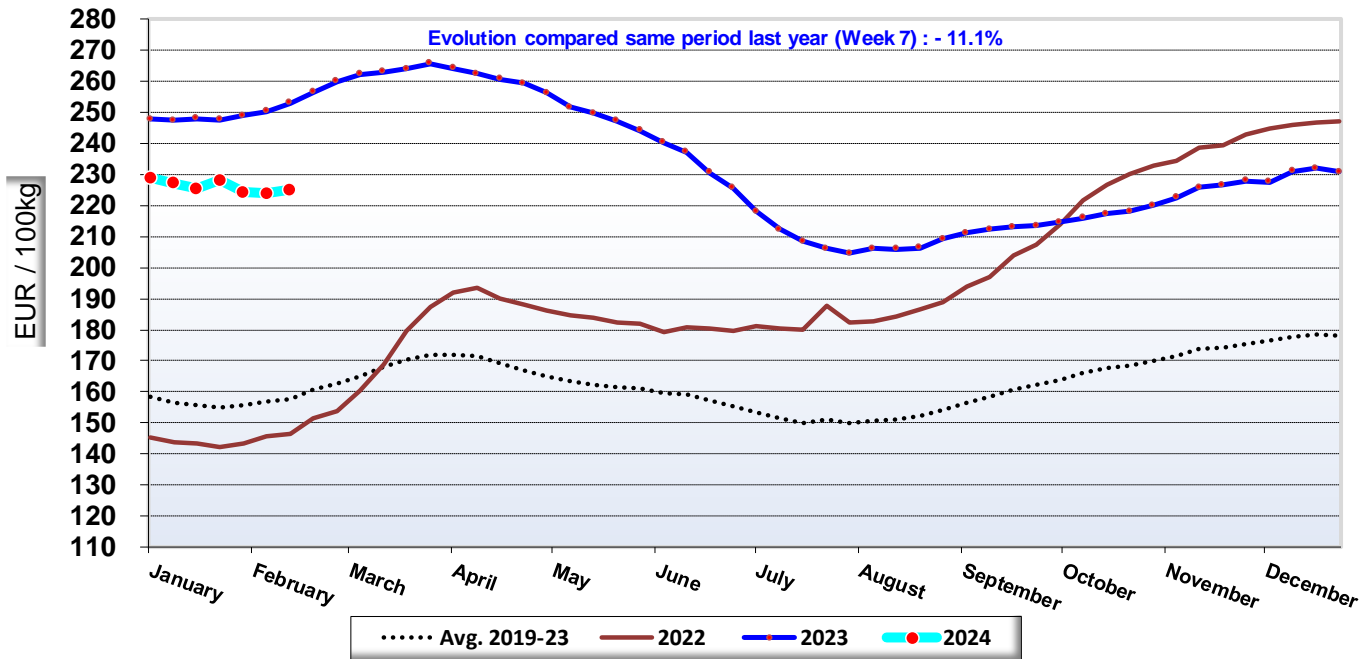
EU placing of laying hens

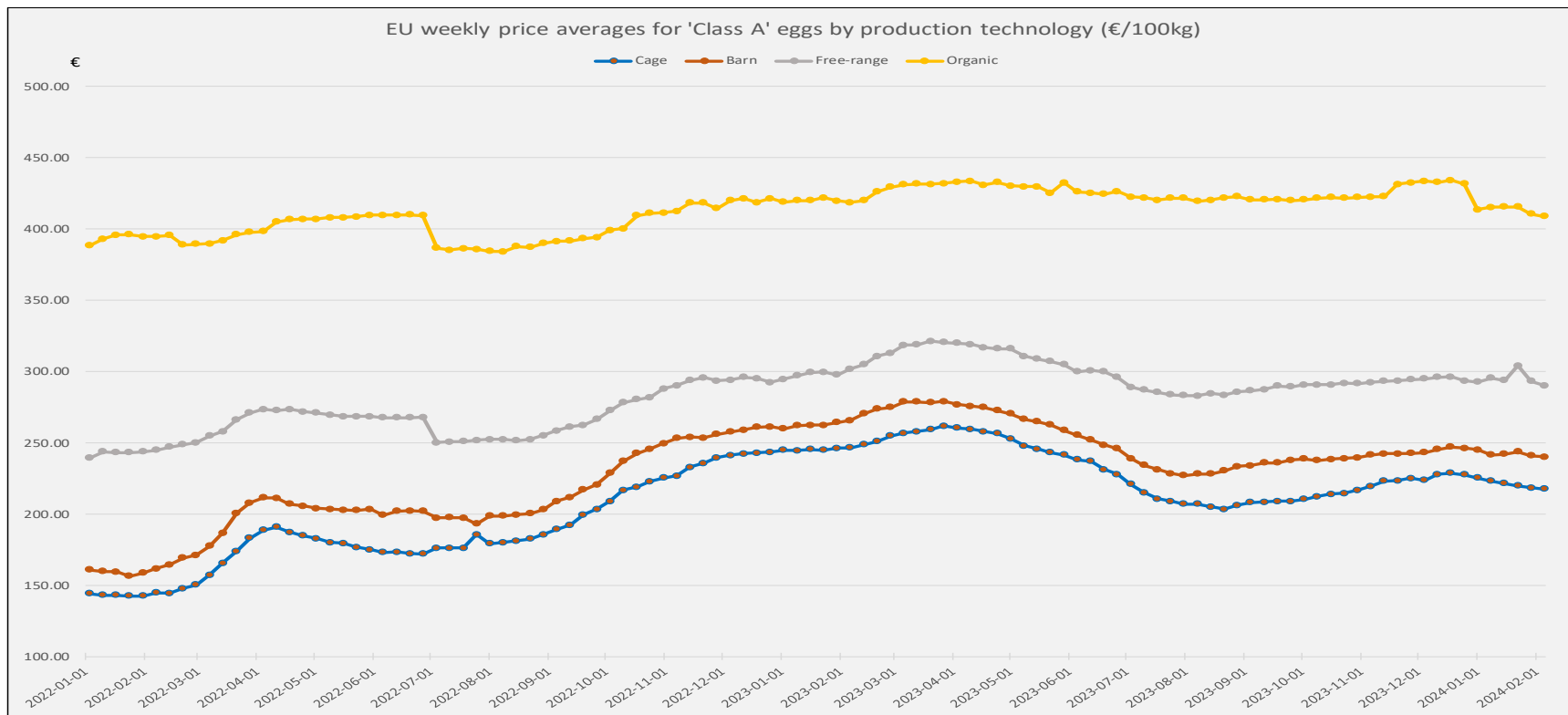

Weekly prices of 'Class A' eggs by production type



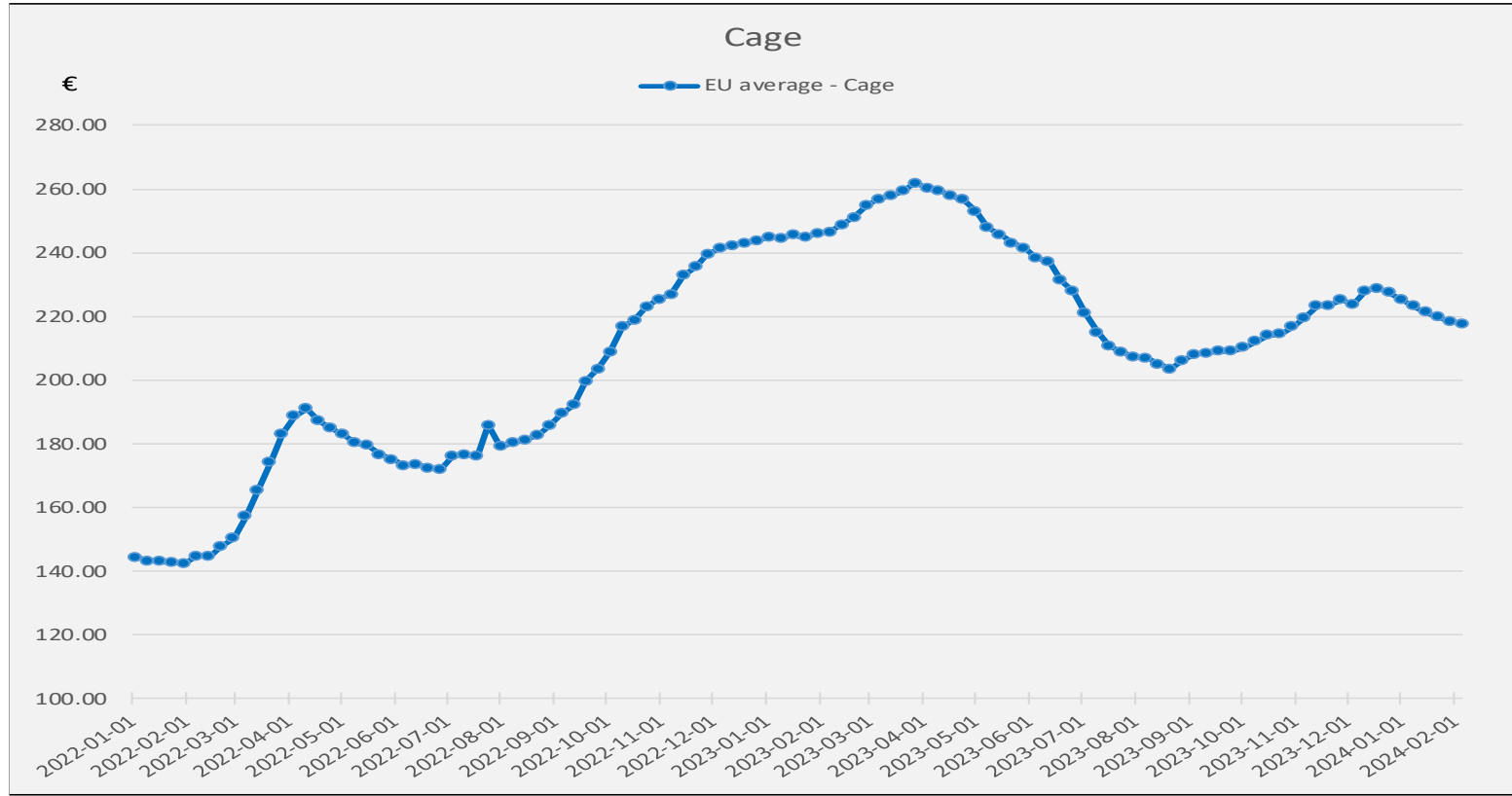

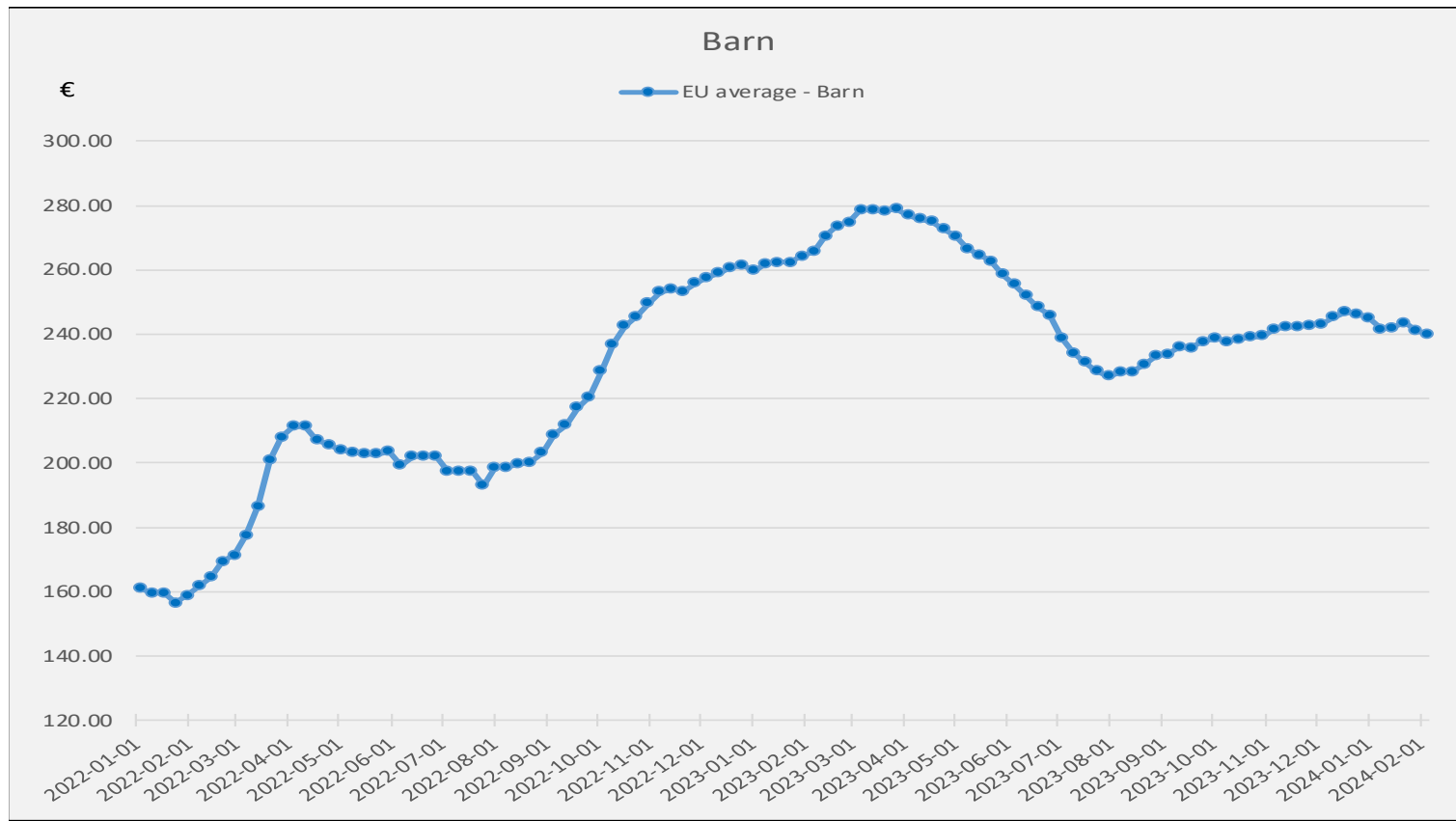

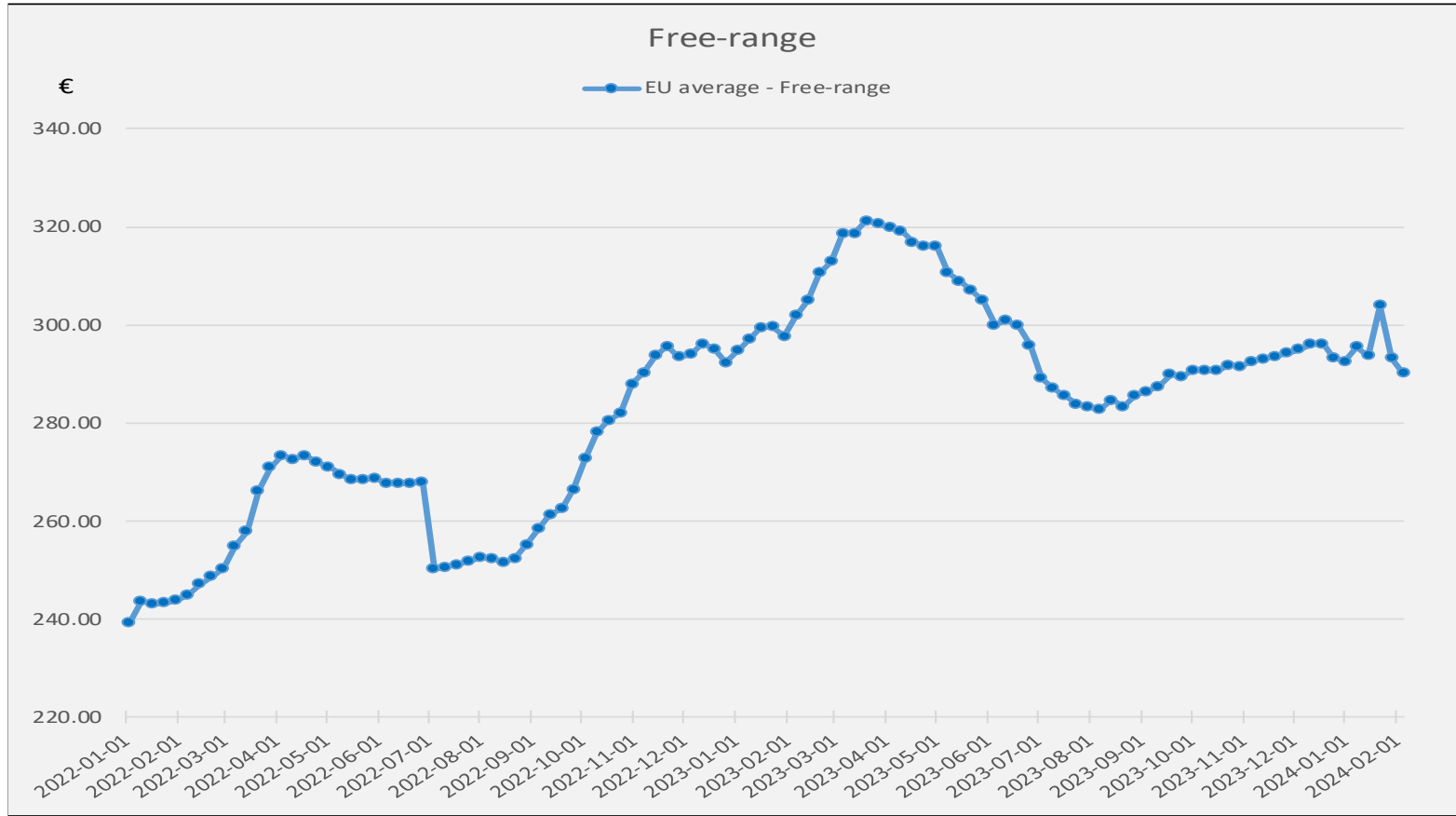

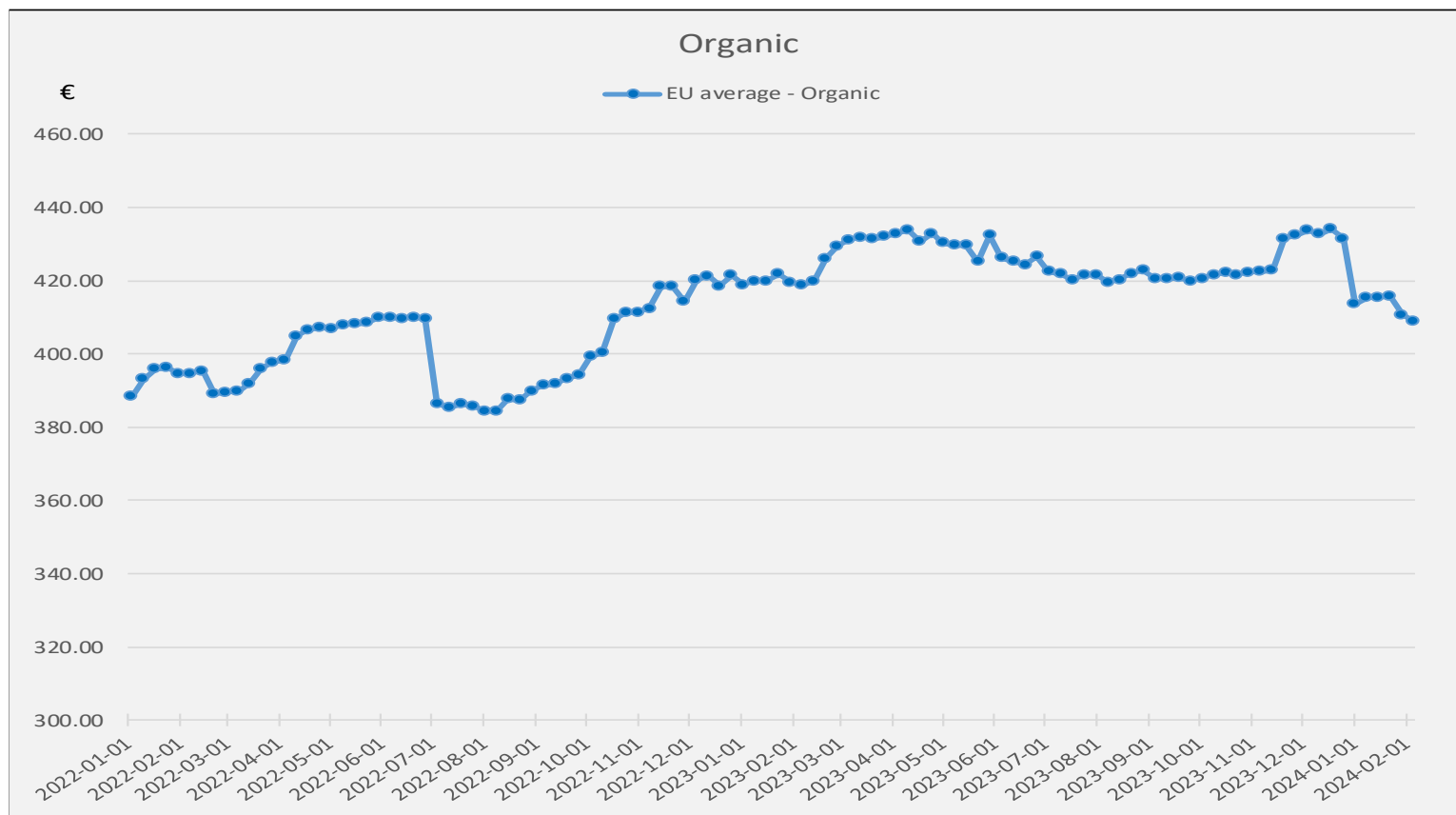

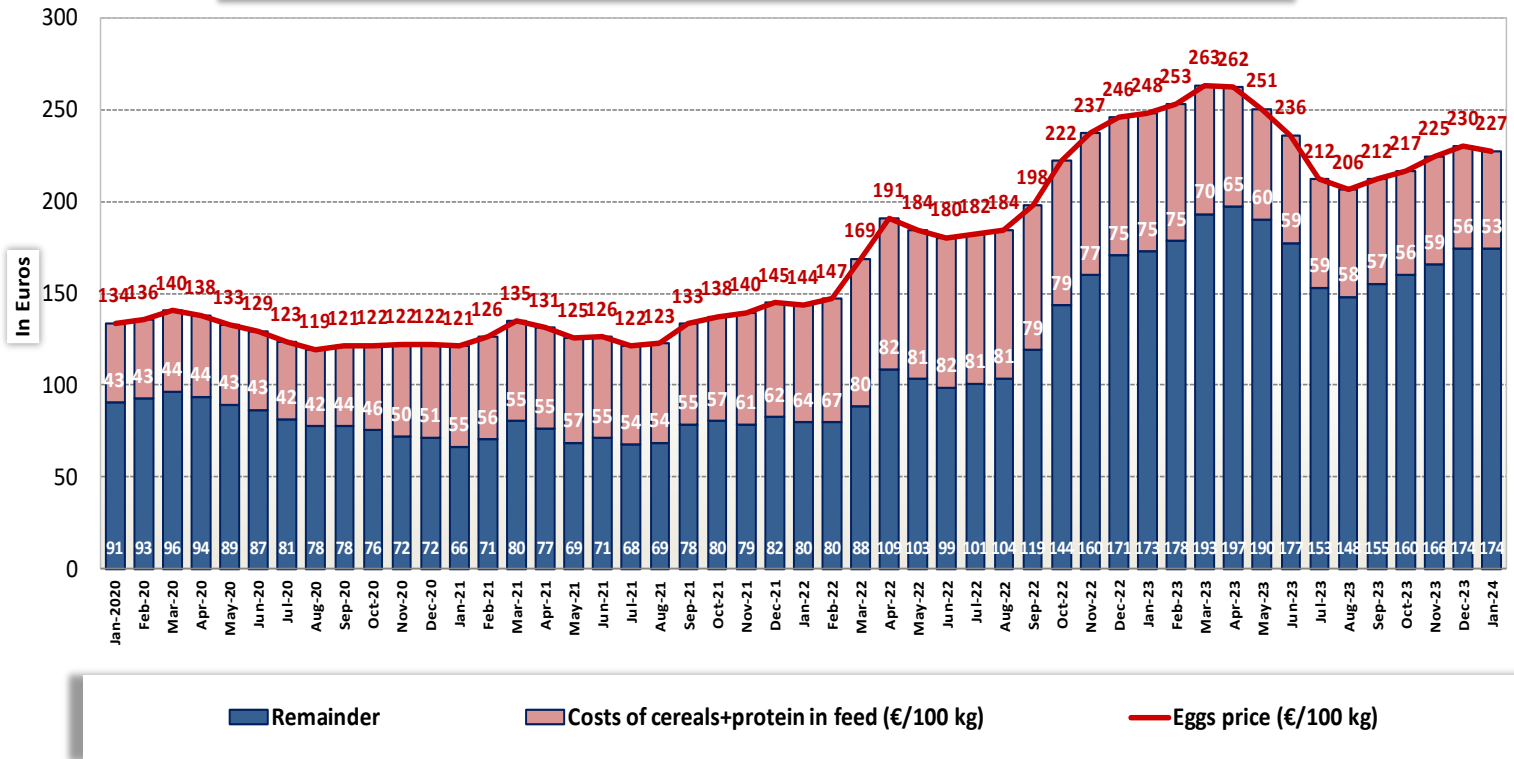

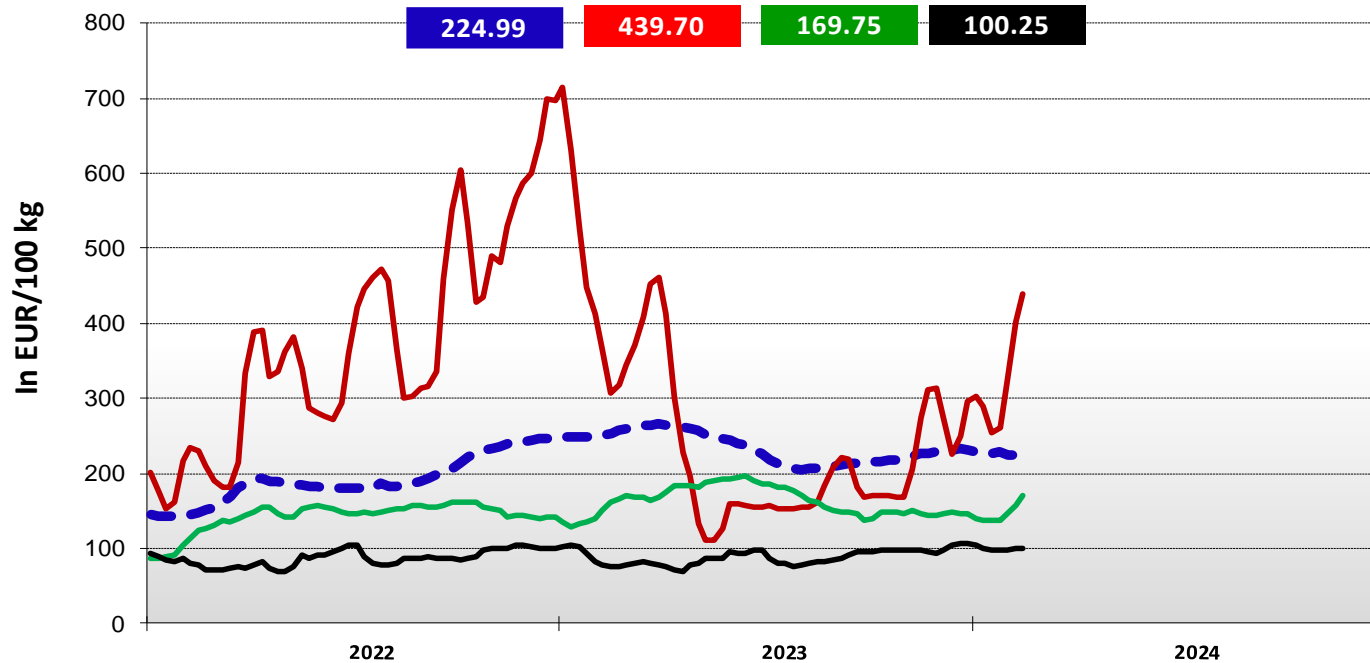
Cost of cereals & protein in feed compared to average 'Class A' egg price

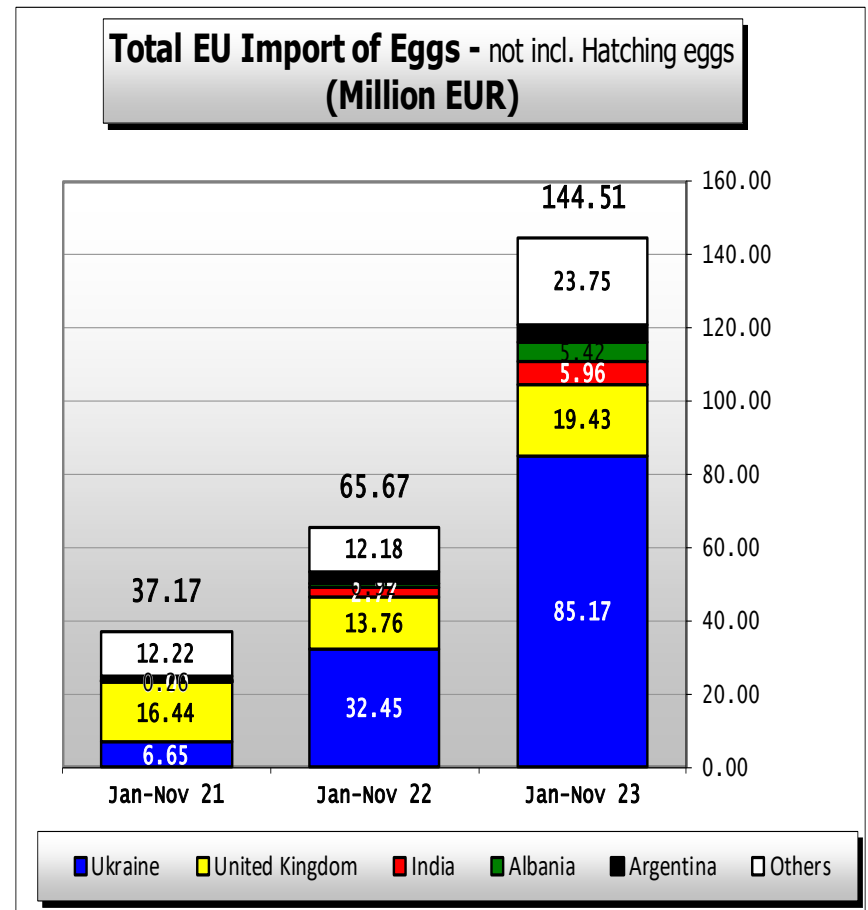
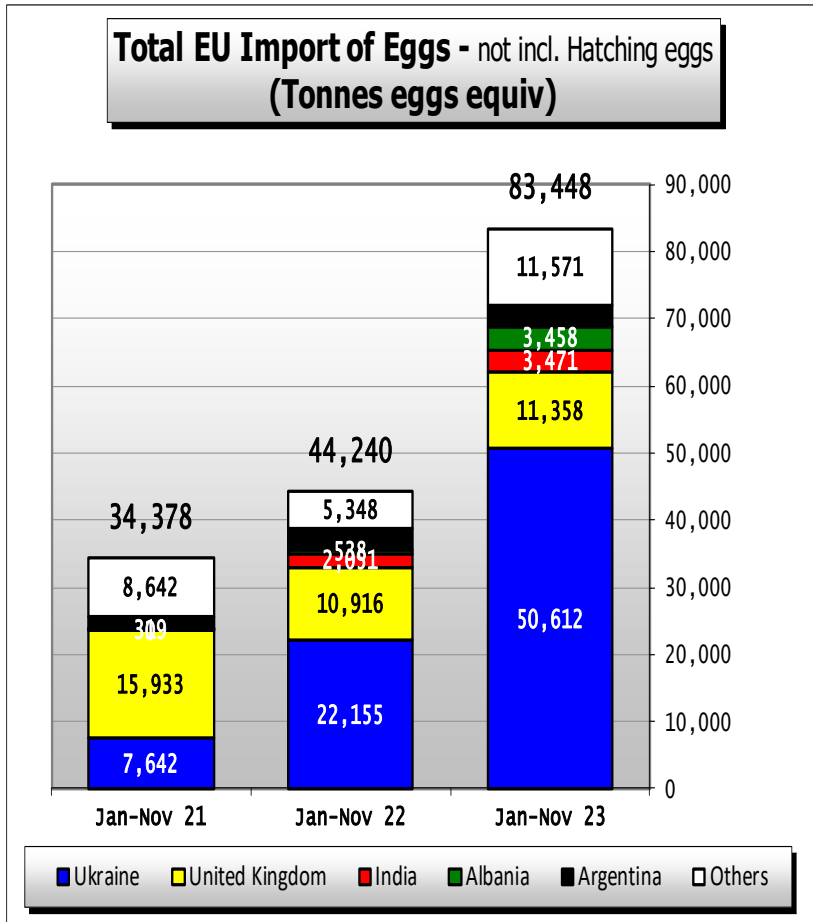

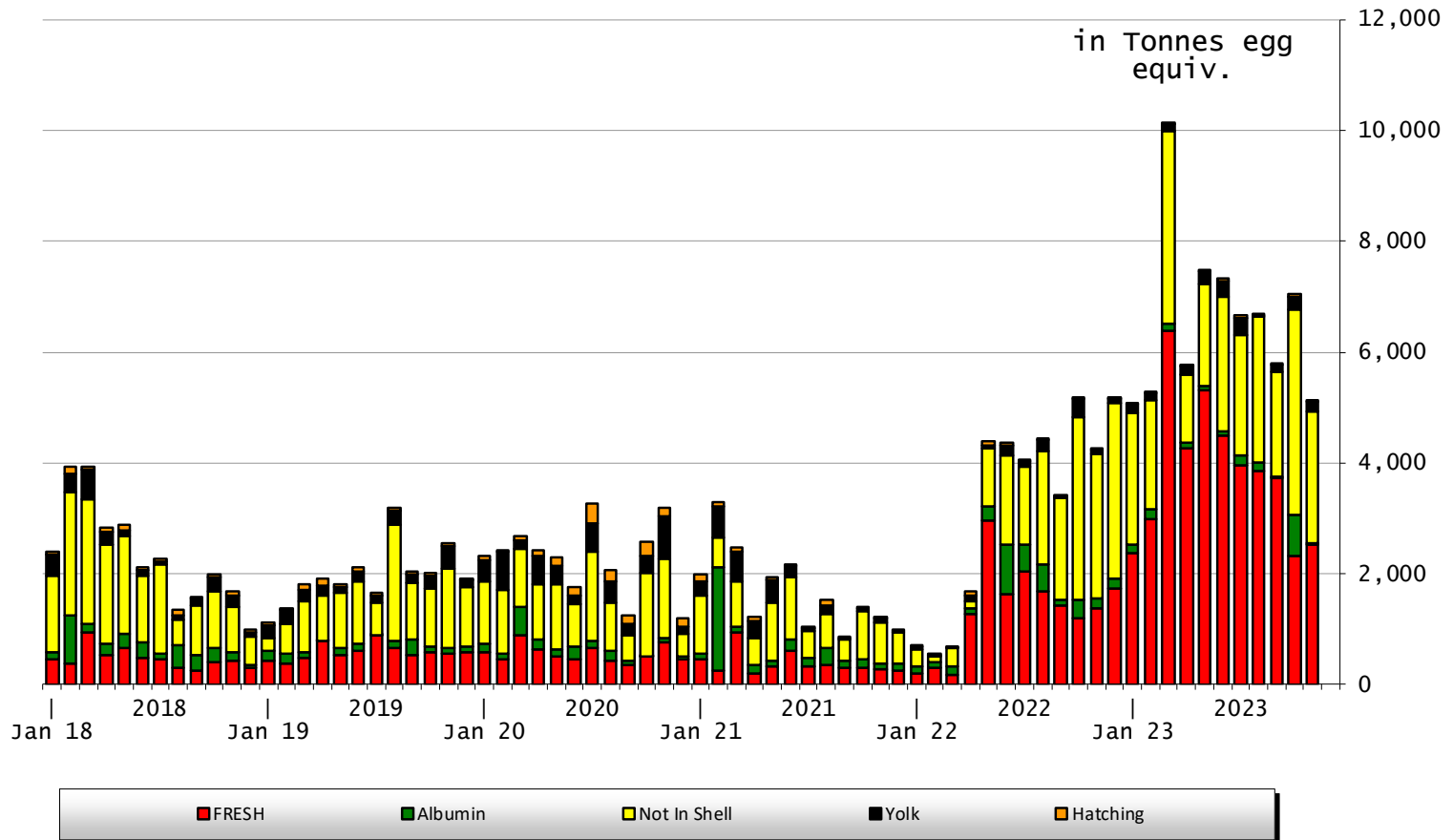

EU-27 Egg Imports



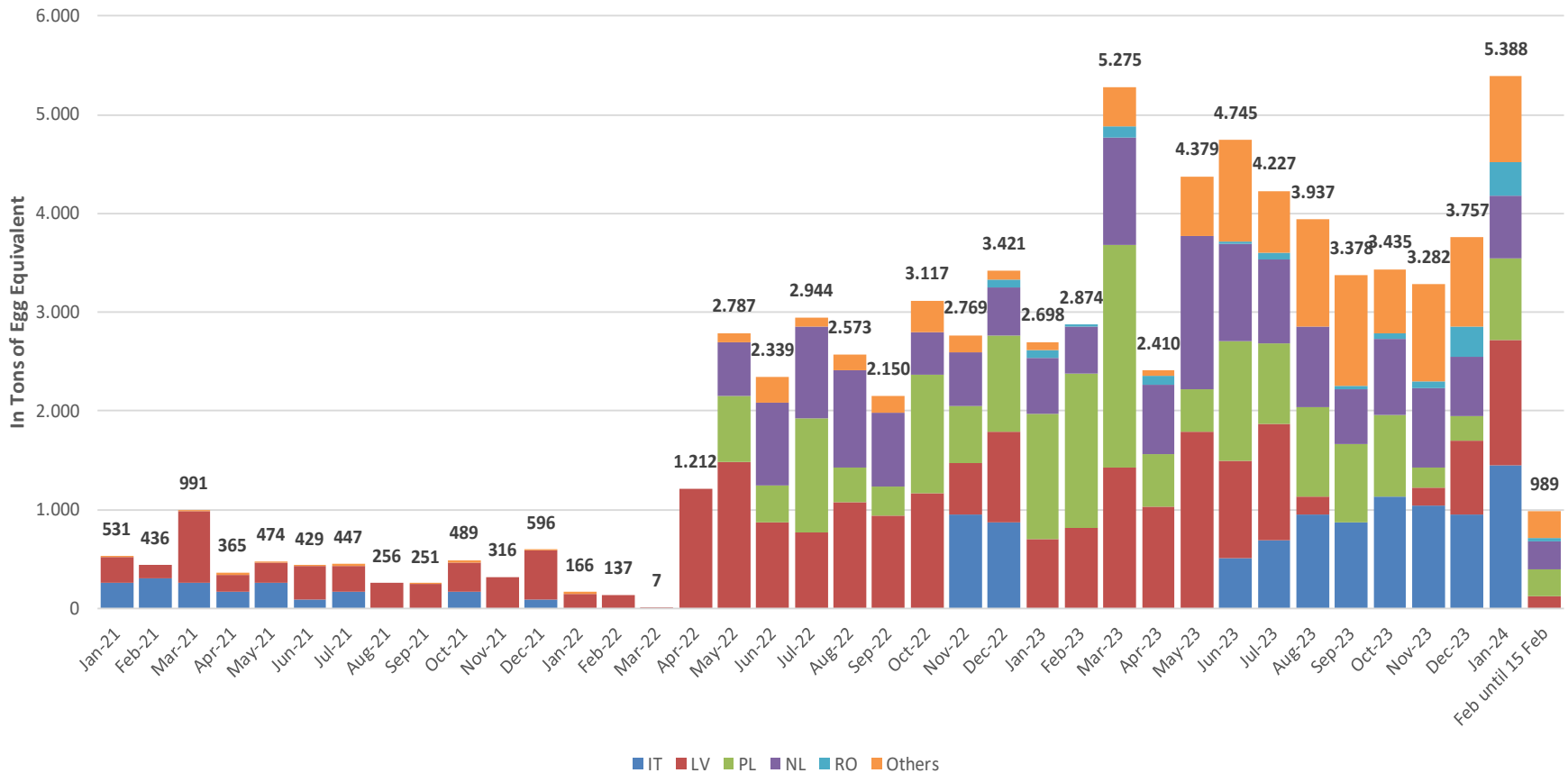

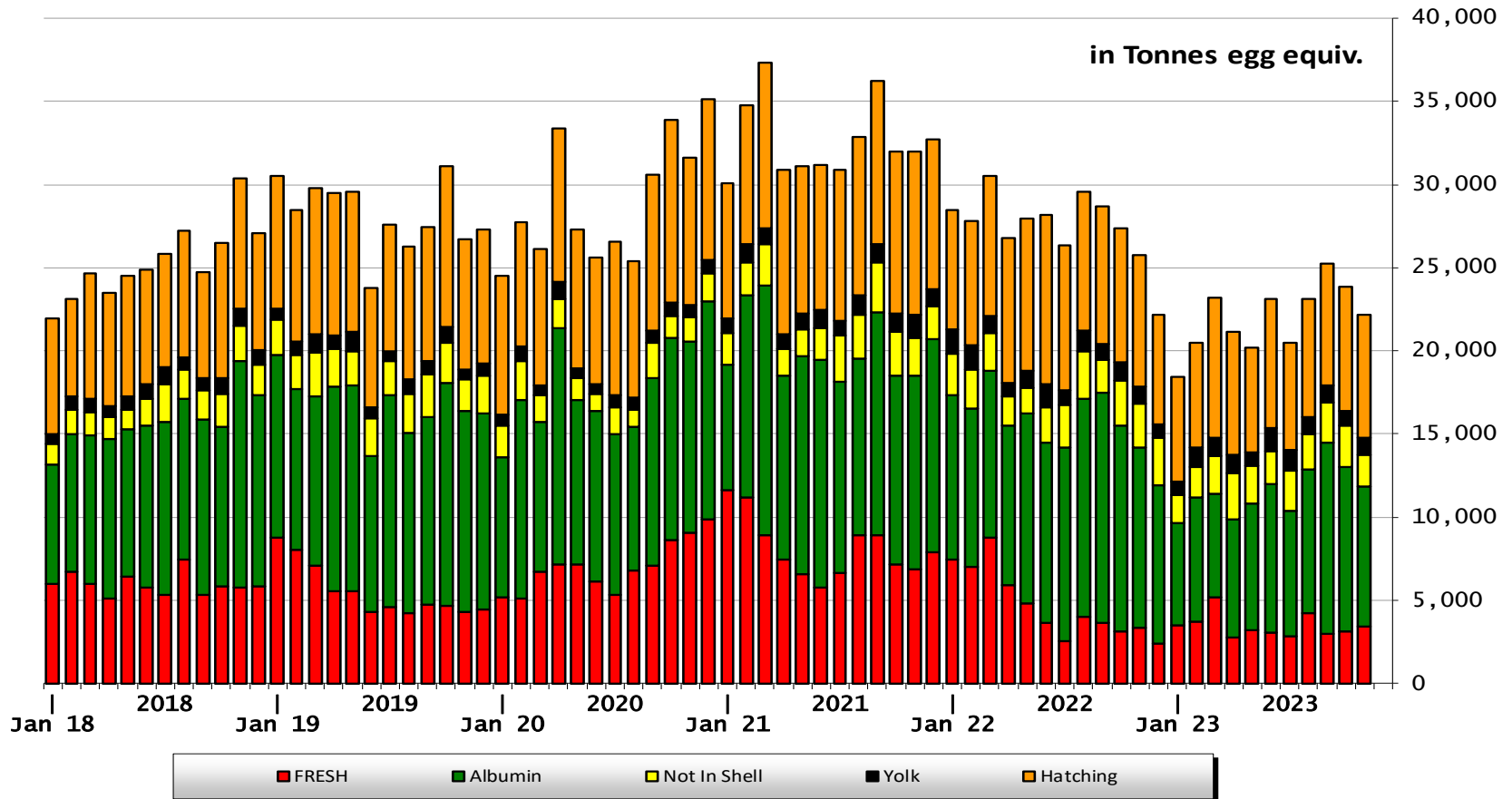

EU-27 Egg Exports



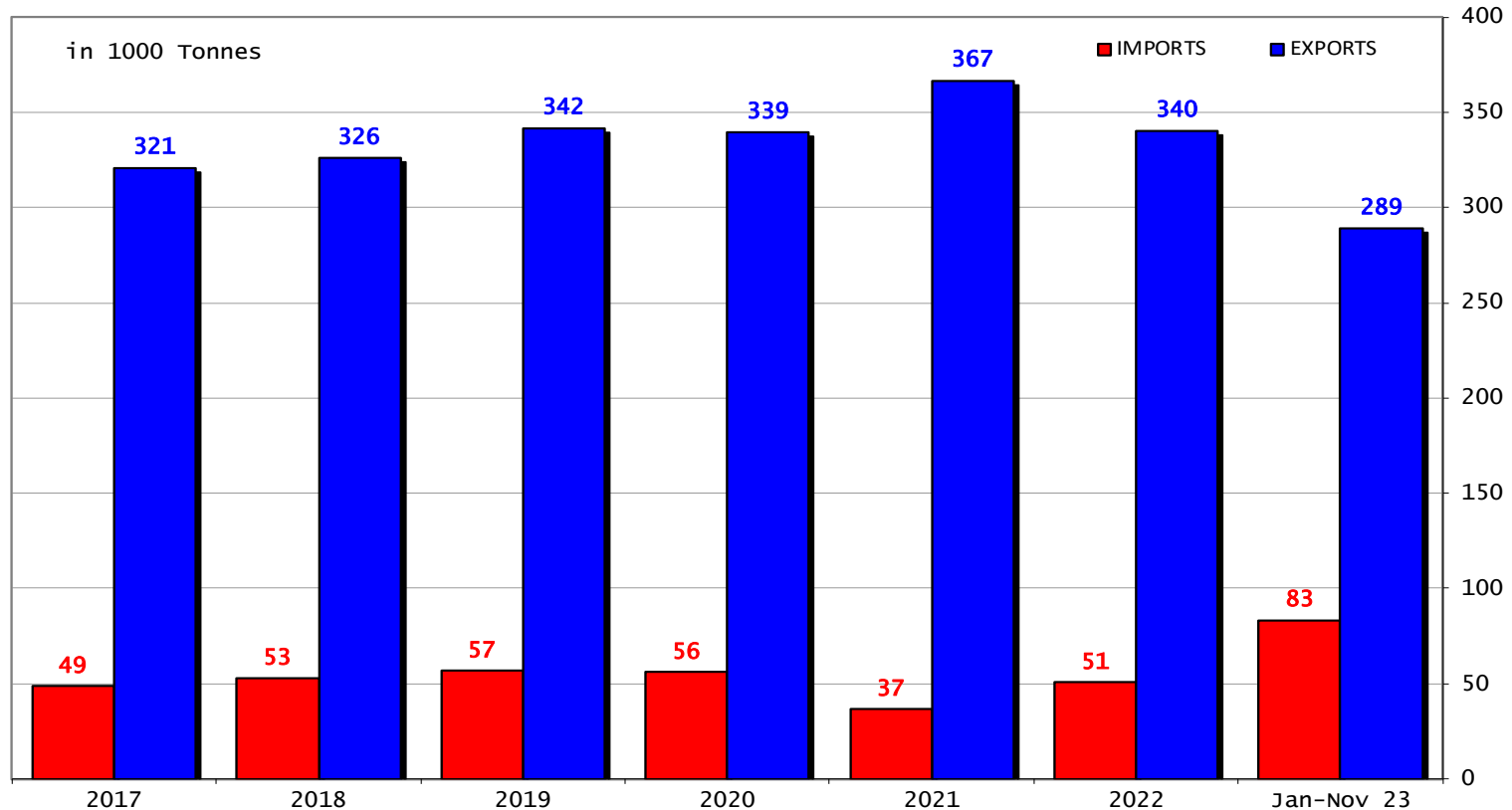

(including Hatching eggs)



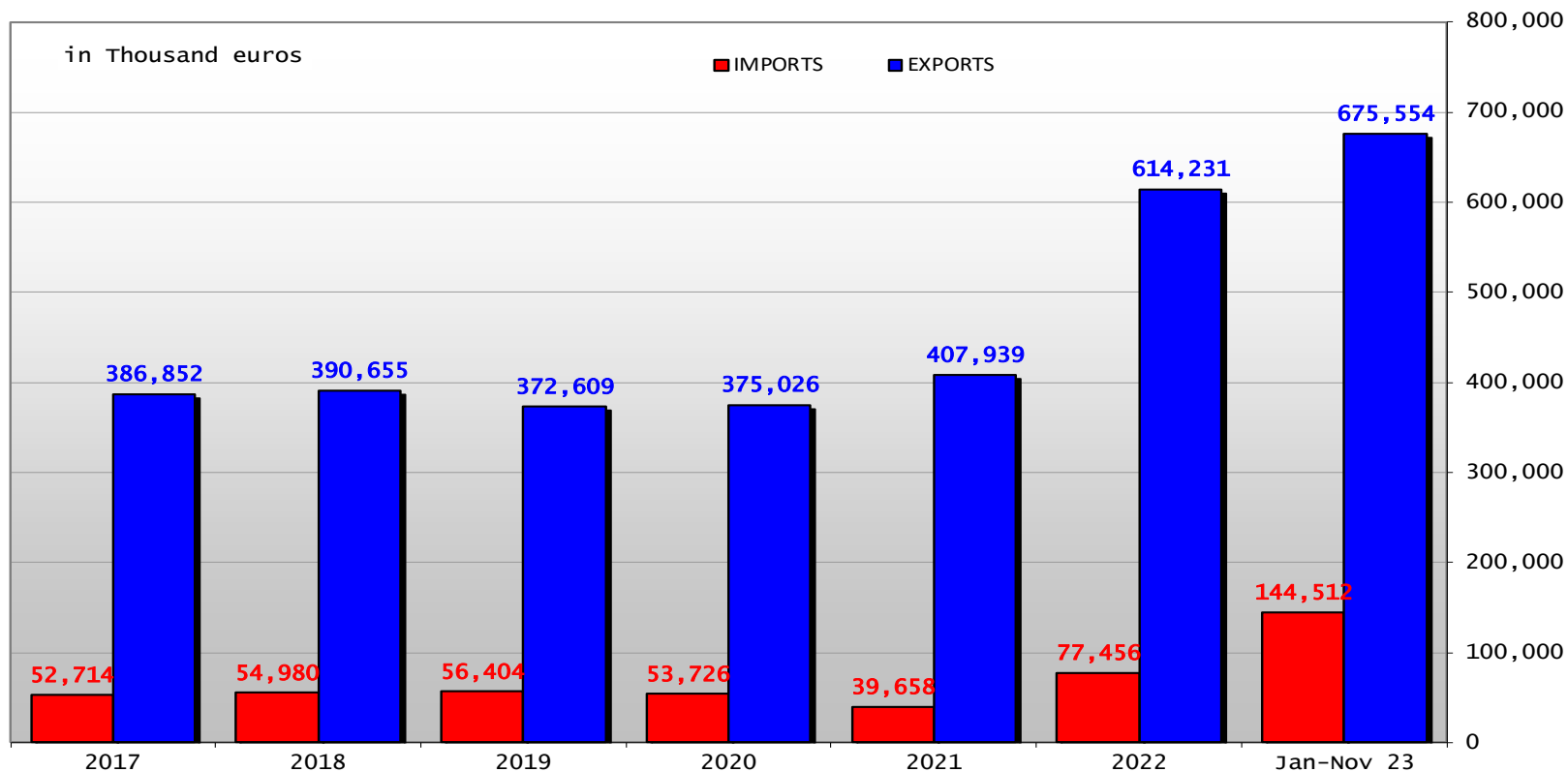
